Chennai Tamil Nadu: Bhagwan Mahavir Foundation (BMF) is dedicated to honor and express gratitude on behalf of the society to individuals and institutions providing selfless service to the weak and underprivileged. The Foundation gives Mahavir Puraskar in four fields namely- non-violence and vegetarianism, education, medicine and community and social service. The winners of the 26th Mahavir Puraskar have been announced. 4 awardees are- Dhyan Foundation, New Delhi (Non-Violence and Vegetarianism); Friends of Tribal Society, West Bengal (Education); Jan Swasthya Sahyog, Chhattisgarh (medical and social service) and Nongstoin Social Service Society, Meghalaya (community and social service).

In this regard, former Chief Election Commissioner of India, Mr. TS Krishnamurthy, member of the selection committee while giving details of the selection process, said that the award winners are doing excellent selfless service in difficult conditions and terrains. Trustee Mr. S. Vinod Kumar said that since inception, 84 award winners have been honored for their excellent selfless service for the welfare of the underprivileged. He also said that this year 4 more awardees have been selected. With the inclusion of a total of 23 States and 1 Union Territory, the number of awardees has gone up to 88. He thanked the selection committee for their support and guidance.

Founder Trustee Shri N. Sugalchand Jain further said that each awardee of the 26th Mahavir Puraskar will be given Rs 10 lakh in cash, a memento and a citation. A total of 324 nominations were considered by the shortlisting committee this year. The selection of awardees is decided by an eminent selection committee headed by Justice Shri MN Venkatachaliah, former Chief Justice of India

Dhyan Foundation, New Delhi – This organization has worked in collaboration with BSF and has rescued around 70,000 animals including bovines and manages more than 43 animal shelters and gaushalas across India. Dhyan Foundation is running 10 ambulances in 5 cities of India. The Foundation organizes temporary shelters. Save the Cow', 'Feed the Dog', 'Help the Monkey' and 'Befriend the Bird' are his popular campaigns.

The 72 villages cater to a population of 41,000 people of whom 67% are vulnerable tribal groups. , JSS provides low-cost care to 3,90,000 patients in over 2,500 villages in Chhattisgarh and adjoining districts of Madhya Pradesh. Tertiary level care is provided under a 100 bedded hospital setup.

Nongstoin Social Service Society, Meghalaya – This organization is engaged in economic empowerment, bringing children, women and persons / children into the mainstream, through economic empowerment, teaching art-skills to the poor and those living in financial distress, as well as good farming Assisting in Telling Practices – Providing guidance, or training, to youth by skill training Organization for the Rights of Persons with Disabilities Helping approximately 39,000 children in difficult and varied circumstances. Also directly integrating 40 villages and 1,000 farmers Technical know-how to promote farming system, efficient use of bio-pesticides and bio-nutrients is the key to improving productivity or production.
