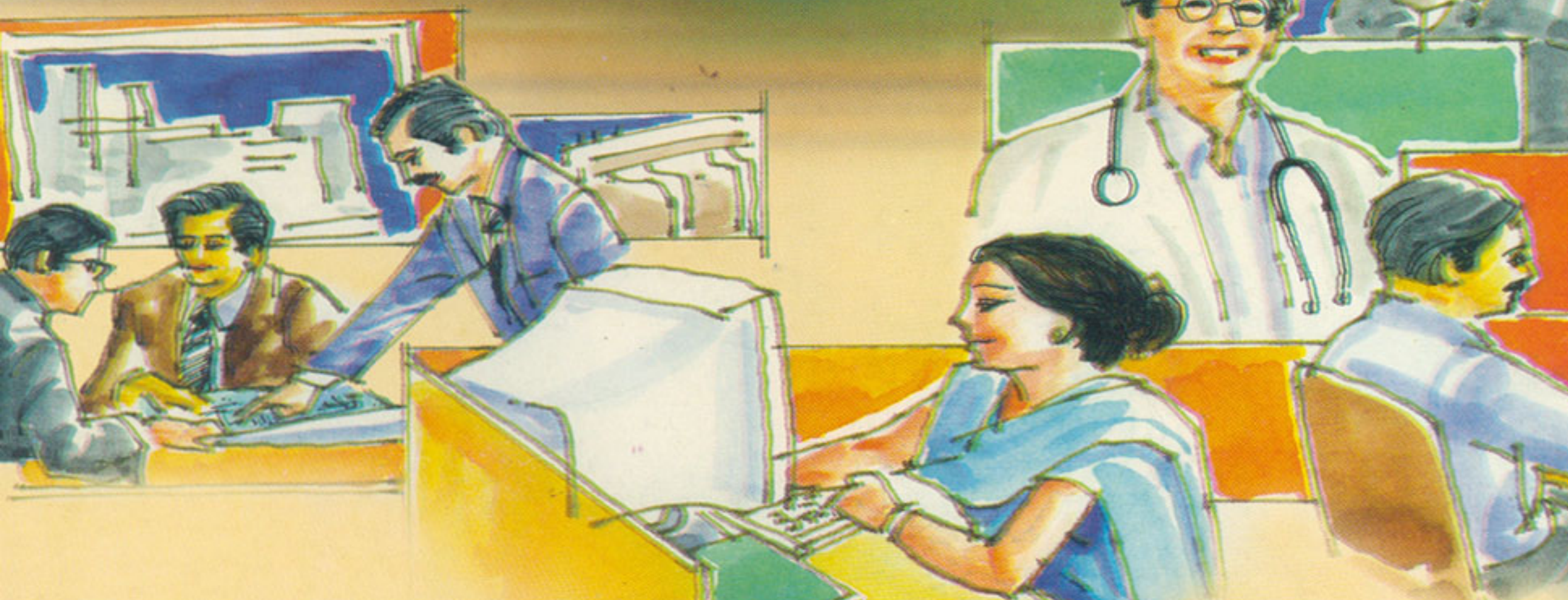
There is a general feeling that the Jain community, as a whole, is quite well off. But in truth, quite a number of them are indigent and yet do not seek others' help. The Trust will go all

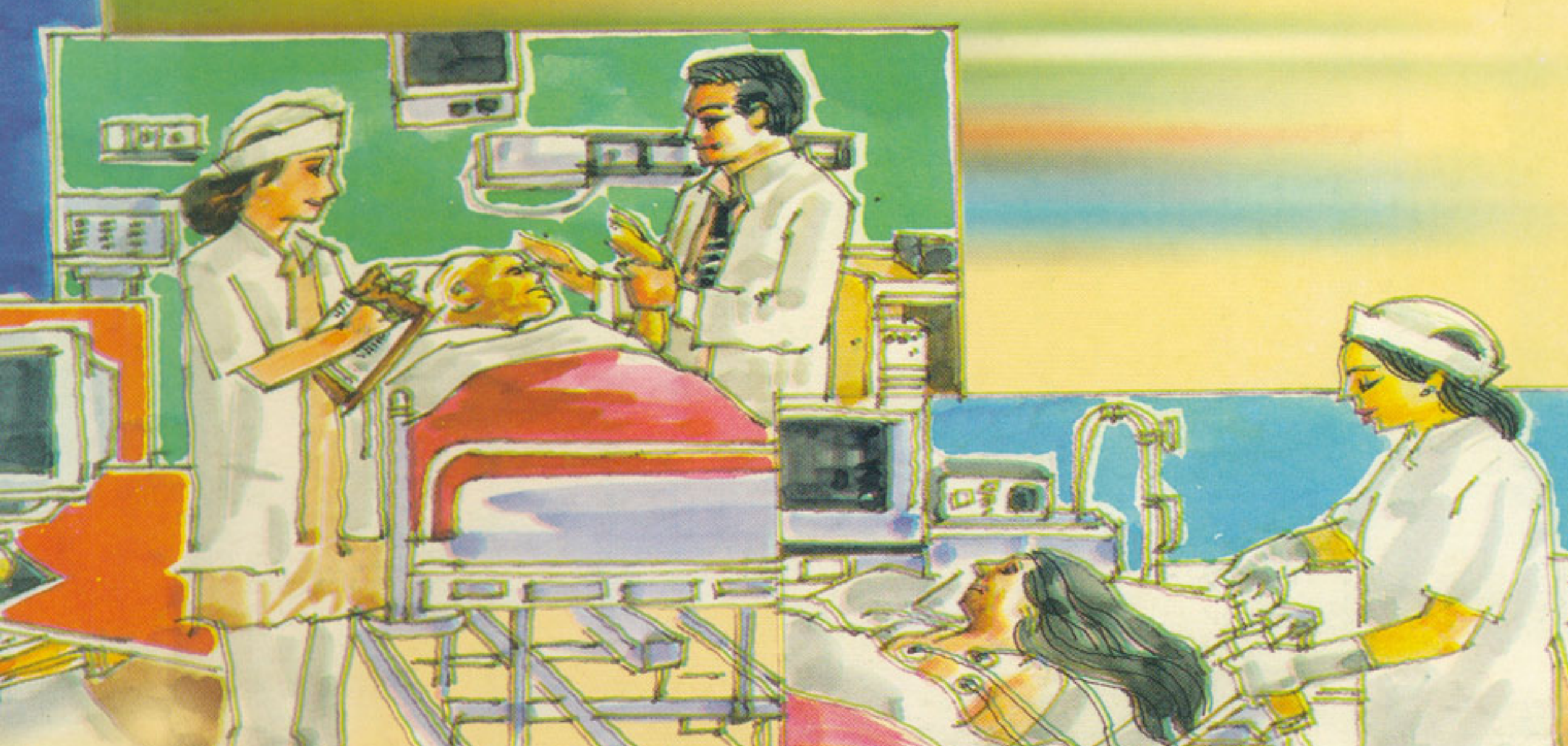
